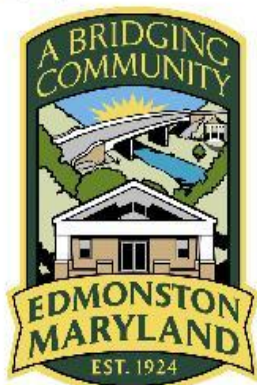

Recent Legislative Actions by the Mayor and Council

May 14th 2012

1. Presentation and introduction of Budget Ordinance 2012-OR-03 Re: Budget FY 2012-2013.

1. Action to retain Lindsey and Associates to conduct budget audit for fiscal year 2011-2012 at a rate not to exceed \$8,600. Motion made by CM Farrish, second by CM White. Motion passed, Mayor Kerns in favor

2. Action to remove "No Parking" signs from the south side of 4600 block of Ingraham Street; subject to certain conditions for a test period of six months. Motion made by CM White, second by CM Farrish. Motion passed, Mayor Kerns in favor

3. Action to approve portrait of Adam Plummer for Town Hall. Motion made by CM Pooley, second by CM White. Motion passed, Mayor Kerns in favor

Mayor's Report

- Today the Maryland General Assembly started a special session to work on the State's budget for Fiscal Year 2013. Tax increases for residents have been proposed. It is important to keep an eye on the State's budget because this will eventually affect the counties' budgets and the municipalities as well.
- As you may have noticed, the work on the levees has started. No word on how long this will take, but keep in mind there is no access to the trails.
- Tonight I will be presenting the Town's budget for everyone's review. Copies of the budget are available.
- There have been some issues in Ward 1 with some parties and speeding with the town. The Police Department has been notified to take corrective action.

Free Energy Audit

The Town of Edmonston recently received a grant which will allow two selected homeowners to obtain a complete Home Energy Audit and retrofits that gives the most "Bang for the Buck" which is likely to be the sealing of your windows and insulation for your attic, at no cost to you!

In order to qualify the home owner must meet certain requirements to be eligible. If you wish to be considered, please call the Town Hall (301)699-8806. Deadline for this project is May 30th, 2012.

Are you having difficulty paying your energy bills? Does your home need energy efficiency retrofits?

According the US Dept of Energy, "checking a home's insulation is one of the fastest and most cost effective ways to use a whole-house approach to reduce energy waste and make the most of your energy dollars."

Homeowner must meet income criteria and be willing to provide documentation that income is BELOW the following:

*The following make the home **ineligible** for this opportunity:*

- Had an energy audit within the past 6 months;
- Aggressive dogs not being safely handled;
- Drug use;
- Threats to auditor;
- Nub and tube wiring (means that you can't install attic insulation);
- Mold problem;
- Water problem such as a hole in roof;
- Home is sealed too tight resulting in the inability of fumes to escape through natural ventilation;
- Major roof issues;
- Major plumbing problems;
- Gas leak;
- Structurally inadequate;
- Rental property;
- Plaster ceiling (which needs a hatch cut to blow insulation into the attic).

Veterans and/or Retired Homeowners will be given preference.

Click it or Ticket Campaign 2012



May marks the beginning of the Maryland Motor Vehicle Administration's Highway Safety Office 2012 Click it or Ticket Campaign. Throughout the month of May and into early June, Maryland law enforcement officers will be aggressively enforcing Maryland's adult seat belt law and child passenger safety laws.

We are seeking your help in spreading the word on Facebook and Twitter about the importance of using seat belts.

The following are a few posts that can be easily pasted into your Facebook pages and Twitter feeds.

- Police are out in force in Maryland issuing tickets to unbelted drivers day and night. In 2010, more than 100,000 citations were issued to unbuckled motorists. Keep your money in your pocket while staying safe. Buckle up day and night.
- Air bags are designed to work with seat belts, not replace them. In fact, if you don't wear your seat belt, you could be thrown into a rapidly opening frontal air bag; a movement of such force could injure or even kill you.
- Younger motorists are particularly at risk when not wearing seat belts. NHTSA data shows that among teen and young adult passenger vehicle occupants in 2010, ages 18-34, who were killed in motor vehicle traffic crashes, 62 percent were not buckled up at the time of the crash – the highest percentage of any age group.
- Statistics show nighttime drivers are less likely to buckle up compared to daytime drivers. Nationally, more than 10,000 passenger vehicle occupants were killed in motor vehicle traffic crashes at night (6 p.m. to 5:59 a.m.) in 2010. Of those killed in nighttime crashes, 61 percent were not wearing seat belts.
- Consistent safety belt use is the single most effective way to protect people from being ejected from a vehicle or being thrown around violently inside it during a crash.
- Drivers and passengers who are hurt or killed in traffic crashes because they didn't buckle up create tremendous economic losses, such as medical expenses and lost worker productivity. The rest of society pays for nearly 75 percent of these economic losses through higher insurance premiums, taxes, and other public funding.
- More than 80 percent of all crashes occur at speeds less than 40 mph. Deaths involving non-belted occupants of cars have been recorded at as low as 12 mph. That's about the speed you'd be driving in a parking lot.
- Three out of four crashes causing death occur within 25 miles of home. Belt up before driving to your local shopping center – just as you would for a long trip.
- Your chances of being killed are almost 25 times greater if you're thrown from the car. The forces in a collision can be enough to throw you as much as 150 feet – about 15 car lengths.
- Safety belts keep you from crashing through the windshield, being thrown out the door and tossed through the air, scraping along the ground, or being crushed by your own car. In any collision, you're better off being held inside the car by safety belts.

SUMMER SAFETY DRIVING TIPS

Neighborhoods are full of all different kinds of people who use the streets, sidewalks, and crosswalks. Most neighborhoods are nice quiet communities but it is important to remember they can be full of surprises and drivers must be constantly vigilant to avoid them. Knowing the common hazards and how to negotiate them can help motorists navigate a neighborhood without problems.

Common Hazards

There are many different types of obstructions or hazards that drivers must watch out for in a neighborhood setting. These include:

- **Children at play.** Children often play in and around streets. They may suddenly run out in front of a car to chase a ball without looking.
- **Roadway obstructions.** Neighborhood streets can become crowded with all kinds of obstructions, such as parked cars, trash and recycling bins, and bags of leaves or discarded materials. Children, pets, and others may dart out between parked cars or from behind obstructions without warning.
- **Blind corners.** Sometimes it can be hard to see around corners because of blocking trees, bushes, mailboxes, light poles, fences, or other obstructions.
- **Pedestrians crossing.** Kids walking to or from school or people walking around the neighborhood with kids or pets may cross the street at the corner or in the middle of the street, sometimes without looking both ways.
- **Bicycles, scooters, and motorcycles.** These two-wheeled vehicles have as much of a right to use the road as do automobiles. Although bicycles and scooters travel slower than cars, this should not be a problem in a

neighborhood in which the speed limit is reduced.

Safety Tips

To avoid these potential safety hazards remember these simple tips:

- **Drive slowly.** By driving at or under the reduced speed limit in neighborhoods you can prevent a severe accident.
- **Exercise caution at intersections and turns.** Look in all directions for potential hazards. If there are children nearby, know that there is a possibility that they will walk out in front of you without looking.
- **Don't tailgate slower vehicles.** Be polite towards bicycles and scooters and keep a safe following distance until you can clearly pass them at a passing distance of greater than three feet.
- **Give pedestrians the right of way.** Look for people in the road or people who are looking to cross, and slow down or stop for them especially if there is a crosswalk.
- **Use your lights.** At night, always use your headlamps to illuminate the road. In especially dark areas where there are no other vehicles present, you may turn on your bright light to help with visibility.

Following these simple tips can help to keep you and other road users safe in your neighborhood.

ECO City Farms is a non-profit that grows food, farms, and farmers. We are offering 2 apprenticeships and 1 internship for the coming main season (April through August).

Farm responsibilities, at minimum, include:

- 1) Harvesting, processing, and marketing produce for our local farmers market, restaurants, and food co-ops.
- 2) Seeding and transplanting seedlings
- 3) Composting and vermi-composting (composting with worms)
- 4) Maintenance (weeding, mulching, feeding with compost tea, and more); and
- 5) Caring for urban livestock (chickens, ducks, fish, bees)
- 6) Helping to direct activities of farm volunteers

Our farm is small, but the work is intensive and demanding. Farmers are often called upon to do different and sometimes tedious jobs in all kinds of weather. Our apprentices and interns must be reliable, on-time, creative, passionate, flexible, fast, and have a good sense of humor in spite of the hard work! We are looking for folks who are willing to work hard when required and enjoy the benefits of being a farmer.

Finding a match between the farm and apprentices/interns is extremely important to the success and satisfaction of both parties. We ask that you fill out the application carefully. - Repeatedly offered courses toward a Certificate in Urban Agriculture with the Prince George's Community College
- Engaged local youth through classroom presentations and "Seed to Feed" six-week summer employment programs.

Support your local urban farm and enjoy fresh, naturally-grown produce all summer long!

ECO City Farms is having a Community Supported Agriculture (CSA) program. CSAs allow consumers to partner directly with a local farm, to share both the bounty and the risks inherent in farming. As a CSA member, you invest in the farm's season. By purchasing your share in advance, you provide the farmer with the capital needed for seeds, supplies and labor to plant the crops. Then, each week of the season, you receive an equal share of the farm's produce.

- *We support each other to ensure you are provided with an ongoing supply of locally grown produce and that the farm is secured financially for the season to focus on farming.*

- *Our Summer CSA runs from June 21 through October 25. In this 19-week period, you are guaranteed 16 weeks of fresh produce. Valued at \$20, your bag may include: heirloom and cherry tomatoes, salad greens, baby spinach, eggplant, hot peppers, baby arugula, radishes, carrots, beets, lettuce, beans, cucumbers, basil, cilantro, chard, parsley, collards, and dill.*
- *We have two pricing offers. Our regular price is \$331.50, which comes out to \$20 per week plus \$11.50 to offset our reduced-fare shares. We are offering 2 reduced-fare shares for those who would like to join the program but may be financially limited. The reduced-fare price is \$240, which can be paid on a monthly basis (\$60 per month). To qualify, we need documentation that you qualify for government assistance.*
- *ECO City Farms is an educational, not-for-profit enterprise located inside the Capital Beltway in Prince George's County, MD designed to serve as a prototype for sustainable local farming. Your purchase of the produce goes towards supporting our mission to cultivate healthier communities by cultivating more local farms and farmers. Five Reasons to Plant Trees

1. Property Values and Commerce

- Treed neighborhoods and business districts attract prospective buyers and consumers.
- In urban areas across the country, homes with trees sell for an average of 10-20 percent more. Consumers are willing to spend 12 percent more in stores with trees in front of them than without.



2. Energy Savings

- Homes shaded by trees have 10-30 percent savings in air conditioning costs compared to homes without shade.
- The shade trees of D.C. save us more than \$2.6 million in air conditioning costs per year.

3. Air Quality

- Trees absorb pollutants and store carbon, reducing the amount of carbon dioxide in the atmosphere.
- The trees of Washington filter 540 tons of harmful, health-threatening pollutants from the air each year.

4. Drainage and Stormwater Mitigation

- Trees help rain soak into the ground rather than run off the surface.
- The decrease in tree cover in D.C. between 1973 and 1997 resulted in an increase of storm water runoff of as much as 34 percent. Overflows lead to sewer backups and flooding including in basements.

5. Health and Quality of Life

- Trees add beauty to neighborhoods, create recreational opportunities and provide relief to physical and visual stress.
- Research shows that kids are better able to concentrate, complete tasks, and follow directions after playing in natural settings.
